Guidance for Visiting in Care Homes

End of Life Visiting

For end of life visits where the home and visitor are both outside of Tier 4, and the home is not in outbreak, the number of visitors (up to a maximum of 3) and frequency of visits is at the home managers discretion unless otherwise stated below.

Where a Home is in Tier 4 or a visitor resides in Tier 4, and their loved one has been identified as in receipt of End of Life care, it has been agreed that 2 individuals from the same household can visit at the same time, and visitors from other households can also visit, but these visits must be on separate occasions and not mixing different households. The caveat to this would be in last hours of life where direct family members wish to visit together, this again should be managed through robust risk assessment.

If there are exceptional circumstances around visiting a resident at End of Life, (for example outbreak in a Home or requests for additional visitors from the same household), then these must be individually risk assessed by a Home Manager.
